Audit opinion - Unqualified

On the basis of my review, in my opinion no matters have come to my attention giving cause for concern that in any material respect, the information reported in this Annual Return:

- has not been prepared in accordance with proper practices;
- that relevant legislation and regulatory requirements have not been met;
- is not consistent with the Council's governance arrangements; and
- that the Council does not have proper arrangements in place to secure economy, efficiency and effectiveness in its use
 of resources.

Other matters arising and recommendations

I draw the Council's attention to the following matters and recommendations which do not affect my audit opinion but should be addressed by the body.

Mis-statement in Line 9 Accounting Statement

Line 9 reports the year end bash and bank balance as £347,225. However, the Council has not taken into account the value of cheques issued before the year end that remained uncleared at 31 March. These items are included in the year end creditors (line 10).

Line 9 should represent the Council's cash position taking into account all payments made before the year end. No adjustments to the accounts should be made in respect of unpresented cheques that are already recorded on the cashbook.

The value of the unpresented cheques is £215 and therefore the error is not material to the reader's understanding of the accounts.
