1. Expenditure under S137 Local Government Act 1972 and S2 Local Government Act 2000

Section 137(1) of the 1972 Act permits the Council to spend on activities for which it has no other specific powers if the Council considers that the expenditure is in the interests of, and will bring direct benefit to, the area or any part of it, or all or some of its inhabitants, providing that the benefit is commensurate with the expenditure. Section 137(3) also permits the Council to incur expenditure for certain charitable and other purposes. The maximum expenditure that can be incurred under both section 137(1) and (3) for the financial year 2023-24 was £9.93 per elector.

In 2023-24, the Council made payments totalling £35,326 under section 137. These payments are included within 'Other payments' in the Accounting Statement.

Auditor General's report and audit opinion

I certify that I have completed the audit of the Annual Return for the year ended 31 March 2024 of **Hawarden Community Council**. My audit has been conducted on behalf of the Auditor General for Wales and in accordance with the requirements of the Public Audit (Wales) Act 2004 (the 2004 Act) and guidance issued by the Auditor General for Wales.

Audit opinion: Unqualified

On the basis of my audit, in my opinion no matters have come to my attention to give cause for concern that, in any material respect, the information reported in this Annual Return:

- has not been prepared in accordance with proper practices;
- that relevant legislative and regulatory requirements have not been met;
- is not consistent with the Council's governance arrangements; and
- that the Council does not have proper arrangements in place to secure economy, efficiency and effectiveness in its use of resources.

Other matters and recommendations

I draw the Council's attention to the following matters and recommendations which do not affect my audit opinion but should be addressed by the Council:

Approval and certification of the Annual Return

The Accounts and Audit (Wales) Regulations 2014 require the Responsible Finance Officer to certify the accounts and the Council to approve the accounts by 30 June 2024. The Regulations further require the chair of the meeting at which the accounts were approved to sign the accounts.

Page 3 of the annual return includes space for this.

We identified that the Council approved the annual return (including the accounting statement) on 10 June 2024. However, we have not been provided with a signed copy of the annual return.

We recommend that in future years, the Council provides a copy of the annual return that has been signed by the RFO and the Chair.

Fixed asset values

The Accounting Statement reports the value of fixed assets as £1,378,921. However, the asset register reports a value of £1,559,805.

We recommend that the Council reviews its valuation of assets to ensure consistency between the asset register and the annual accounting statement.

Approval of payments

The Council's internal controls require approval of all payments before payments are made. We identified a small number of payments that appear not to be recorded in the Council's minutes as approved.

We recommend that the Council reviews its arrangements to ensure all payments are approved as required by the Council's internal control system.

There are no further matters I wish to draw to the Council's attention.
