3. PURCHASE OF NEW COUNCIL VEHICLE:

Members of the Council will recall that at its budget meeting in January 2022 the purchase of a new van was agreed circa £25,000 to be taken from the Council's reserves. This is for the maintenance team and the cost will be split between the three councils.

Due to the pandemic, vans have been particularly difficult to obtain and the team have actively been looking for a new vehicle. One was viewed but the team had been informed that it had already been sold, one other was viewed but was not large enough for the council's requirements. A third vehicle has been sourced from Evans Halshaw in Hull, via video link at the Bretton show room. This vehicle appears to be fit for purpose and is priced at £18,990 plus VAT.

The Council's contribution from reserves will be £9,685 with Broughton and Bretton contributing £3,646 and Shotton to pay £5,659. Although Broughton and Bretton and Shotton Town Council may not have enough reserves to pay for their share until April 2022.

Council is asked to consider approving the purchase of this van.
