### **572/17 MEMBERS' INFORMATION ITEMS**

Councillor Joyce Angell had recently attended a Planning Workshop for Community and Town Councils that had been delivered by Planning Aid Wales via funding received from the Welsh Government. Workshops had taken place in each of the 22 local planning authority areas in Wales and focussed on the development management side of planning.

Councillor Angell said that the workshop had been enlightening and informative and that the frustrations about planning had been shared across a number of Town and Community Councils. Thirty-four Community Councillors had attended the Flintshire event which had been the highest attendance rate.

Councillor George Hardcastle shared with Members some concerns about the planning application at Church Lane and concerns that the development appeared to be deviating from the original planning application. Councillor Hardcastle had been in contact with the Planning Officer who had confirmed that he would closely monitor the development and involve enforcement colleagues if necessary. Members asked the Clerk to write to the Planning Authority to outline the Community Council's concerns.
