COUNCIL MEETING:

1. APOLOGIES FOR ABSENCE:

Received from Councillors Doreen Mackie (Shotton TC meeting), Dale Selvester (Work) and Ant Turton (Work).

2. DECLARATIONS OF INTEREST:

There were none.

3. MINUTES OF THE PREVIOUS MEETING:

Approved and accepted, save and except, that a minute's silence had been held following the sad death of the husband of Councillor Margaret Redfern.

4. MATTERS ARISING FROM THE MINUTES:

5. CHAIRMAN'S REMARKS:

The Chairman had attended the Sacred Heart Carol Service.

6. VACANCY IN ASTON WARD:

A by-election had been called by residents in Aston. The election would take place on Thursday 16th February, 2023 if contested.
